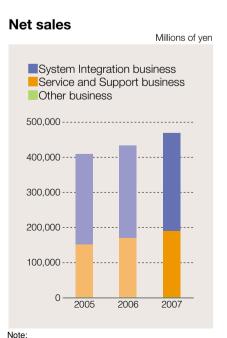

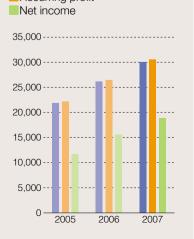

# Operating income, Recurring profit, Net income Millions of yen




# Total assets, Interest-bearing debt

# **To Our Shareholders and Investors**



I am pleased to announce the results for the fiscal year ended December 31, 2007.

In the fiscal year under review, the OTSUKA Group posted net sales of \$469,481 million, which was an increase of 8.3% from the previous fiscal year. By segment, net sales in the System Integration business rose 6.2% to \$279,753 million as a result of robust sales in the information security-related business and color copiers. In the Service and Support business, net sales increased 11.1% to \$187,358 million on the back of a strong showing by the "tanomail" office supply mail-order service as well as the "tayoreru" IT and business support service.

Earnings reached another record high owing to the OTSUKA Group's successful endeavors to hold down selling, general and administrative (SG&A) expenses relative to higher sales. Operating income rose 14.9% to \$30,051 million, recurring profit increased 15.2% to \$30,520 million, and net income jumped 20.7% to \$18,856million, resulting in five consecutive terms of increased sales and income.

In view of these results, management has resolved to set year-end dividends per share at ¥130.

In line with its Mission Statement, the OTSUKA Group will continue to pursue management reforms to ensure the trust of all stakeholders. In these endeavors, your continued support is greatly appreciated.

# **Overview of Consolidated Operations**

# Sustained Mild Economic Expansion

In the fiscal year under review, despite a growing sense of uncertainty about the future fueled by the emergence of rising crude oil prices and the impact of the U.S. subprime loan issue, the Japanese economy continued to be in a phase of mild economic expansion on the back of improved corporate earnings and an increase in capital spending.

In the IT-related industrial sector in which the OTSUKA Group operates, IT investments by major corporations demonstrated significant growth and were robust for small and midsized companies as well. In addition to strengthening management foundations by streamlining and raising performance of information processing, IT investment needs included handling computerization of legal and official procedures, establishing internal control systems, bolstering information security countermeasures and developing information system infrastructure.

# Proposing Information Systems that Utilize Comprehensive Strengths

Amid these conditions, the OTSUKA Group remained dedicated to its fiscal 2007 slogan "Respond to customers' trust from their viewpoint and grow with customers" by strengthening functionality and greater use of "SPR," a system developed by OTSUKA CORPORATION that combines the functions of customer relationship management (CRM) and sales force automation (SFA) programs. The Group utilized its comprehensive strengths to conduct aggressive proposals that integrated copiers, computers, facsimiles, telephones and communication lines.

Further, we continued to focus resources on the information security-related business, the "ODS21" knowledge management system, "SMILE" integrated mission-critical systems, as well as the "tanomail" office supply mail-order service and the "tayoreru" IT and business support service. Additionally, the Group worked to raise development quality and productivity by enhancing operating efficiency with the expansion of operations at the Sales Support Center, as well as by strengthening project management in system development projects.


# Five Consecutive Terms of Increased Sales and Income

On a consolidated basis, net sales rose 8.3% to ¥469,481 million, operating income increased 14.9% to ¥30,051 million, recurring profit expanded 15.2% to ¥30,520 million and net income jumped 20.7% to ¥18,856 million, resulting from the effect of an extraordinary gain on the transition of retirement benefit plan. This was the fifth consecutive term of increased sales and income.

Cash provided by operating activities amounted to ¥16,654 million as a result of such factors as an increase in income before income taxes and minority interests, compared with ¥13,909 million in the previous term.

Cash used in investing activities amounted to \$4,555 million owing to such factors as a decrease in payments for purchase of investments in securities, compared with \$7,161 million in the preceding term. Cash used in financing activities amounted to \$4,271 million, compared with \$1,250 million in the preceding term, stemming from such factors as an increase in the amount of cash dividends paid.

# **Overview of Business Segments**

### System Integration Business

The System Integration business provides optimized system services ranging from consulting to system design and development, transport and installation work and network construction. Due to favorable conditions in the information security-related business, color copiers, the "ODS21" knowledge management system and CAD systems, net sales increased 6.2% to ¥279,753 million.


### Service and Support Business

The Service and Support business provides customers with total support for installed systems encompassing supplies, hardware and software maintenance, telephone support, IT education and outsourcing. The "tanomail" office supply mail-order service via the Company's Website and catalog channels, as well as the "tayoreru" service that offers maintenance support to customers, are collectively known as the accumulated business, which generated solid growth. As a result, net sales amounted to ¥187,358 million, 11.1% higher than the preceding fiscal year.

### Other Business

In the Other business, net sales amounted to ¥2,370 million, representing a 59.0% increase from the previous fiscal year.


# **Focus More Energy on the Accumulated Business**


# Accumulated Business (Non-consolidated)



"tanomail" and "tayoreru" are the core pillars of the accumulated business.







The corporate scale of the Company's customers spans a wide range from major enterprises to small firms.


Viewed from an annual sales scale, in recent years the ratio of companies with an annual sales of ¥10 billion and above is increasing.

# **Forecast for Fiscal 2008**

### Utilization of IT Essential

Looking ahead, it appears that improvements in corporate earnings and the employment situation will come to a standstill, which together with reports of worsened business confidence give rise to an increasingly prevalent cautious view of the future. Further, there is concern that the impact of the U.S. subprime loan issue and the high cost of crude oil will have a negative effect on the economy, both in Japan and worldwide.

Within this context, companies of every size and industry must increasingly employ IT in order to resolve management issues. In particular, upon the enactment of the Financial Instrument and Exchange Law, IT investment related to the implementation of internal control systems is projected to increase and demand for the upgrading of information system infrastructures is expected as well.

In accordance with such conditions, the OTSUKA Group has set as its fiscal 2008 slogan, "Respond to customers' trust from their viewpoint and make a leap forward together with customers," and will offer high value-added information system proposals that utilize its comprehensive strengths. The OTSUKA Group will provide optimal customer support and work to further expand its business with existing customers while cultivating new customers.

In the System Integration business, the OTSUKA Group will continue to focus resources on the key strategic businesses of the information security-related business, the "ODS21" knowledge management system, the "SMILE" integrated mission-critical operational system and CAD systems. In the Service and Support business, the OTSUKA Group will further strengthen the office supply mail-order service "tanomail" and the support service "tayoreru," which are collectively known as the accumulated business.

On an operational level, together with aggressive investment in internal information systems, the OTSUKA Group will further strengthen its sales support structure, reinforce product management in system development projects and raise support quality and productivity.

The Company is promoting the acquisition of new customers with "tanomail," and by reinforcing the "tayoreru" menu will provide one-stop solutions for supporting customers' business across the board.

#### 3. Promote further development and utilization of "SPR"

Further development and utilization of the "SPR" customer relationship management and marketing support system will be pursued to promote optimal proposals and increased efficiency.

# Forecast for Fiscal 2008

For fiscal 2008, the Company forecasts a 4.2% increase in net sales to \$489,000 million; a 2.8% rise in operating income to \$30,900 million; a 2.2% increase in recurring profit to \$31,200 million; and a 15.0% decline in net income to \$16,030 million owing to the effect of an extraordinary gain on the transition of retirement benefit plan recorded in fiscal 2007.

By segment, projections call for a 0.3% increase in net sales to \$280,600 million in the System Integration business; a 10.1% rise in net sales to \$206,200 million in the Service and Support business; and a 7.2% decline in net sales to \$2,200 million in the Other business.



# New Distribution Centers Established in Kyushu and Chubu Regions

### Otsuka Information Technology Corp. Removed from Scope of Consolidation

Otsuka Information Technology Corp. (Taiwan), formerly a consolidated subsidiary of OTSUKA CORPORATION, was converted from a subsidiary to an affiliate accounted for using the equity method on December 31, 2007, as a result of the dissolution of direct control by the Company. Consequently, the Company currently has eight consolidated subsidiaries.

# **Social Contribution and Environmental Preservation Activities**

### "A Gift from Tanokun"

# **Corporate Governance**

### Basic Stance Regarding Corporate Governance

Based on a corporate ethic and spirit of compliance spelled out in its Mission Statement, the OTSUKA Group aims to adapt nimbly to changes in the environment and augment its competitiveness by ensuring thorough compliance and raising both operational transparency and fairness.

#### Current Status of Implementation of Corporate Governance Measures

As a company with a Corporate Auditors system, OTSUKA CORPORATION aims to augment corporate governance by further enhancing the General Shareholders Meeting, augmenting the auditing capabilities of Corporate Auditors, reforming the Board of Directors and making an active and ongoing commitment to disclosure and investor relations (IR) activities.

#### 1. Enhancement of the General Shareholders Meeting

The OTSUKA Group believes that enhancement of the General Shareholders Meeting is crucial to improving corporate governance, and is working to ensure that as many shareholders as possible attend meetings, while concurrently introducing an electronic voting system that will allow shareholders to exercise their voting rights via the Internet.

#### 2. Board of Directors

As of December 31, 2007, the Board of Directors consisted of 14 Directors, of which 12 board members concurrently serve as Executive Officers responsible for making decisions and overseeing business operations based on actual on-site conditions. There are no outside directors at present.

The Board of Directors meets regularly twice a month to discuss critical management issues as well as to deliberate on progress regarding businesses performance and make swift decisions toward resolving relevant issues. Group Management Meetings comprising top management of all Group companies are also held to clarify operational conditions at each company and progress in achieving profitability in addition to working to strengthen corporate governance.

As of March 27, 2008, there were 15 Directors.

#### 3. Executive Officer System

OTSUKA CORPORATION introduced the Executive Officer System on July 1, 2003, and has since been working to realize more rapid decision-making in regard to management policies and execution of business operations as well as to strengthen the oversight structure for more efficient business operations. Consequently, the Board of Directors handles overall decision-making for important management matters as well as supervisory functions pertaining to business operations. Executive Officers elected by the Board of Directors are responsible for execution of business operations as decided by the Board of Directors and under the direction of the President. As of December 31, 2007, there were 34 Executive Officers, (12 of whom are Directors).

As of March 27, 2008, there were 31 Executive Officers (13 of whom are Directors).

#### 4. Corporate Auditors System

OTSUKA CORPORATION uses a Corporate Auditors system. The Board of Corporate Auditors is comprised of four auditors that include two outside auditors, all of whom attend such important meetings as Board of Directors meetings and management meetings to monitor that the management of operations is being properly carried out. The Corporate Auditors reinforce auditing at the operational level through such means as identifying potential problems at an early stage by regularly engaging in dialogue with management via the Board of Corporate Auditors along with independent auditors, as well as by collaborating and coordinating with internal departments conducting auditing of subsidiaries and affiliates.

No personal, capital or business interests exist between outside auditors and OTSUKA CORPORATION.

On July 31, 2007, MISUZU Audit Corporation, the Company's independent auditor at that time, was disbanded and ceased independent auditing services. Consequently, the Company appointed Ernst & Young ShinNihon on August 1, 2007 as a temporary independent auditor.

Furthermore, Ernst & Young ShinNihon, the Company's temporary independent auditor, was selected and subsequently approved to assume the position as the Company's independent auditor at the General Meeting of Shareholders on March 27, 2008.

There are no interests among MISUZU Audit Corporation or Ernst & Young ShinNihon, Managing Partners responsible for auditing the Company and OTSUKA CORPORATION.


#### 6. Status of Monitoring Operations

Critical items that impact operations and performance are reported immediately to the Board of Directors and the Board of Corporate Auditors as they arise. Moreover, the Office of Auditors under the direction of the President has been established to conduct periodic and on-demand internal audits of all operations and assess the adequacy of policies, plans and procedures, the effectiveness of their implementation in operations and progress in compliance, as well as to offer concrete advice and recommendations for improving operations and raising awareness. The Office of Auditors has 15 staff as of December 31, 2007.

OTSUKA CORPORATION has established and operates an Internal Reporting and Improvement Proposal System that allows employees to directly report and propose improvements to the President. The purpose of the system is as follows:

- To quickly identify, address and prevent occurrences pertaining to dishonesty and misconduct in relation to corporate ethics and fair trade
- To assess, suitably handle and prevent such incidences as abuse of authority and sexual harassment
- To receive proposals and consultation, as well as to individually address issues related to business operations and work flows

As of December 31, 2007, the structure for corporate management decision-making, business operations and oversight is as follows:



# The following measures were implemented recently to strengthen corporate governance.

#### (As of March 30, 2006)

In order to promote the separation of the execution of business operations by Executive Officers and oversight by Directors, OTSUKA CORPORATION has separated the positions of Executive Officers to include Senior Executive Operating Officers and Operating Officers. Respective Directors' positions, except the Chief Executive Officer and Executive Managing Director, will remain the same. (As of April 1, 2006)

In response to the Whistleblower Protection Act, which came into effect from April 1 2006, OTSUKA CORPORATION has strengthened its conventional Internal Reporting and Improvement Proposal System by establishing a "Compliance Hotline" as a means of improving the convenience of reporting procedures and explicitly further protecting the confidentiality of informants. In doing so, the Company seeks to take action early on through effective and swift response by rapidly gathering risk-related information from inside and outside the Company.

#### (As of May 16, 2006)

In order to realize a fundamental stance related to corporate governance, a resolution of the Company's "Basic Policy Regarding Improvement of the Internal Control System" was passed at the Board of Directors meeting on May 16, 2006. As the basic policy of carrying out business operations, the Company aims to respond quickly to environmental changes and enhance its competitiveness by pursuing thorough compliance and greater management transparency and fairness, thereby pursuing agile and continuous improvement and augmentation of its internal control system.

### Remuneration for Board Members and Auditors

1) Remuneration for Directors and Corporate Auditors in the current fiscal year is as follows.

### Number of Directors

The Company's Articles of Incorporation as of December 31, 2007 stipulate that the number of Company Directors shall be 19 or fewer.

### Requirements for Resolution of Director Appointments

The Company's Articles of Incorporation stipulate that a resolution for appointment of Director requires attendance by shareholders with more than one-third of the voting rights of shareholders capable of exercising such rights, and is decided by a majority of voting rights.

### Requirements for Special Resolution of the General Meeting of Shareholders

The Company's Articles of Incorporation stipulate that a special resolution of the General Meeting of Shareholders, pursuant to Article 309, Paragraph 2 of the Company Law, shall be adopted when it is approved by a vote of two-thirds or more of the voting rights present at a General Meeting of Shareholders, a quorum for which shall be the presence of shareholders of one-third of the aggregate voting rights of the total shareholders capable of exercising such rights. This aims to facilitate efficient operation of the General Meeting of Shareholders through the moderation of special resolutions at the General Meeting of Shareholders.

# **Business Risks**

The most common risks that could potentially impact the Group's business performance results and financial condition are outlined below. While these are the most common risks, they do not represent all potential risks.

The items covered herein are possible future occurrences determined by OTSUKA CORPORATION as of March 27, 2008.

### Customer-Related Risks

OTSUKA CORPORATION customers range from large enterprises to small firms across a wide range of industries. Consequently, its level of dependency on any specific customer is low.

However, the Group's operations could be impacted by convergent changes in IT investment trends by a large number of companies as a result of unexpected changes in the economic environment.

### Supplier-Related Risks

The OTSUKA Group is supplied with high-quality products, services and technologies (hereafter called "products") by numerous suppliers for respective segments in order to optimally resolve the problems of each customer. While working to deepen its relationship with suppliers to ensure stable supply of these "products," the Group is constantly working to acquire information on newer "products" as well.

However, the Group's operations could be impacted by the inability to supply "products" in the quantity demanded by customers because of insufficient supply of "products" due to issues at supplier sites, as well as by the Group's inability to obtain substitutes.

#### Information Leakage Risks

The OTSUKA Group possesses an abundance of individual and corporate information pertaining to operations that is handled carefully.

The Group received approval to use the Privacy Mark of the Japan Information Processing Development Corporation, and its Internet Data Center acquired certification for Information Security Management Systems (ISMS).

As a concrete measure to manage data, the Group has released an internal and external Personal Information Protection Policy, as well as established regulations on personal information protection, confidentiality and information system security. The Group has its employees take a pledge of confidentiality as well as works to prevent information leakage outside of the Group and raises awareness of information management through its proprietary educational "CP (Compliance Program) License System" and other measures. Even with these measures, however, the Group's operations could be impacted by assuming liabilities for damage and loss of trust by society in the unlikely event that personal or corporate information is leaked outside the Group.

#### Sales Summary

In the fiscal year under review, the System Integration business and Service and Support business both recorded robust sales, and consolidated subsidiaries also did well as a whole. As a result, consolidated net sales reached a record high for the fifth consecutive fiscal year, increasing 8.3% to ¥469,481 million.

#### System Integration Business

The System Integration business provides optimized system services ranging from consulting to system design and development, transport and installation work and network construction. Due to favorable conditions in the information securityrelated business, color copiers, the "ODS21" knowledge management system and CAD systems, net sales increased 6.2% to ¥279,753 million.

#### Service and Support Business

The Service and Support business provides customers with total support for installed systems encompassing supplies, hardware and software maintenance, telephone support, IT education and outsourcing. The "tanomail" office supply mailorder service via the Company's Website and catalog channels, as well as the "tayoreru" service that offers maintenance support to customers, are collectively known as the accumulated business, which generated solid growth. As a result, net sales amounted to ¥187,358 million, 11.1% higher than the preceding fiscal year.

#### Other Business

In the Other business, net sales amounted to ¥2,370 million, representing a 59.0% increase from the previous fiscal year.

#### Summary of Income and Expenses

Gross profit increased 5.4% to ¥109,046 million, and the gross profit margin was 23.2%.

As a result of efforts to reduce selling, general and administrative (SG&A) expenses, operating income rose 14.9% to ¥30,051 million.

Recurring profit reached a record high for the seventh straight fiscal year, increasing 15.2%, to ¥30,520 million, as a result of an increase in non-operating income stemming from equity in net income of unconsolidated subsidiaries and affiliates.

As a result of posting a gain on the transition of retirement benefit plan of ¥4,298 million, income before income taxes and minority interests increased 27.5% to ¥33,597 million.

In aggregate, net income increased 20.7% to ¥18,856 million, and net income per share was ¥596.69.

#### Assets

Total assets increased ¥11,026 million to ¥200,383 million. Current assets rose ¥14,121 million, to ¥130,353 million, as the favorable results achieved by the Company were reflected by increases in cash and time deposits and other cash equivalents and accounts and notes receivable. Fixed assets decreased ¥3,094 million to ¥70,030 million.

#### Liabilities

Total liabilities declined ¥3,559 million to ¥112,382 million. Current liabilities increased ¥4,271 million, to ¥108,551 million, attributable to an increase in income taxes payable. Long-term liabilities declined ¥7,831 million, to ¥3,831 million, owing to a decline in the reserve for retirement benefits.

#### Net Assets

Total net assets rose ¥14,586 million, to ¥88,000 million, owing to such factors as an increase in retained earnings. As a result, the equity ratio rose 5.0 percentage points to 43.5%.

The interest coverage ratio was 217.30 times; the interest-bearing debt ratio was 5.02%; return on equity (ROE) was 23.55%; and return on assets (ROA) was 15.51%.

#### **Cash Flows from Operating Activities**

Net cash provided by operating activities increased ¥2,745 million (19.7%) to ¥16,654 million. This is mainly due to an increase in income before income taxes and minority interests, as well as decreases in income taxes paid and the reserve for retirement benefits.

#### **Cash Flows from Investing Activities**

Net cash used in investing activities declined ¥2,606 million (36.4%) to ¥4,555 million, mainly due to payments for purchase of investments in securities in the previous fiscal term.

Free cash flows, which are the sum of cash provided by operating activities and cash used in investing activities, increased ¥5,351 million to ¥12,099 million.

#### **Cash Flows from Financing Activities**

Net cash used in financing activities increased ¥3,021 million (241.7%) to ¥4,271 million. This is chiefly attributable to an increase in cash dividends paid.

As a result of the above factors, cash and cash equivalents at end of year increased ¥7,069 million (38.6%) to ¥25,374 million.

#### Outlook

For fiscal 2008, the Company forecasts a 4.2% increase in net sales to ¥489,000 million; a 2.8% rise in operating income to ¥30,900 million; a 2.2% increase in recurring profit to ¥31,200 million; and a 15.0% decline in net income to ¥16,030 million owing to the effect of an extraordinary gain on the transition of retirement benefit plan recorded in fiscal 2007.

By segment, projections call for a 0.3% increase in net sales to ¥280,600 million in the System Integration business; a 10.1% rise in net sales to ¥206,200 million in the Service and Support business; and a 7.2% decline in net sales to ¥2,200 million in the Other business.

# 1. Basis of Presenting the Consolidated Financial Statements

### Accounting Principles

The accompanying consolidated financial statements of OTSUKA CORPORATION (the "Company") and its subsidiaries are prepared on the basis of accounting principles generally accepted in Japan, which are different in certain respects as to the application and disclosure requirements from International Financial Reporting Standards, and are compiled from the consolidated financial statements prepared by the Company as required by the Company Law and the Financial Instruments and Exchange Law of Japan.

Certain items presented in the consolidated financial statements have been reclassified for the convenience of readers outside Japan.

The consolidated financial statements are not intended to present the consolidated financial position, results of operations and cash flows in accordance with accounting principles and practices generally accepted in countries and jurisdictions other than Japan.

#### 2. Summary of Significant Accounting Policies

## (1) Scope of consolidation

The Company had 15 subsidiaries (majority-owned companies) and 13 subsidiaries as at December 31, 2006 and 2007, respectively. The consolidated financial statements include the accounts of the Company and ten subsidiaries and eight subsidiaries for the years ended December 31, 2006 and 2007, respectively.

The eight subsidiaries which were consolidated in the year ended December 31, 2007 are listed below:

The Company and its consolidated subsidiaries are hereinafter referred to as the "Companies."

Generally, Companies that are owned more than 50 % are classified as subsidiaries and companies that are owned more than 20 % are classified as affiliates. However, companies that are owned between 40 % and 50 % may also be classified as subsidiaries and companies that are owned between 15 % and 20 % may also be classified as affiliates, if the Company substantially controls the investees' management or has significant influence and relationships with the investees, respectively.

The consolidated subsidiaries listed above apply a fiscal year ending on December 31 of each year, which is the same as that of the Company.

The accounts of the remaining five unconsolidated subsidiaries as at December 31, 2006 and 2007, consisted of insignificant amounts in terms of total assets, net sales, net income and retained earnings, and have, therefore, been excluded from consolidation.

#### (Fiscal year 2007)

Fujimi Construction Co.,LTD, a consolidated subsidiary, and Netplan Co.,Ltd, a consolidated subsidiary,have merged in April 2007, and been operating as Netplan Co.,Ltd.

Otsuka Information Technology Corp. was changed from a consolidated subsidiary to an affiliate which was accounted for the equity method effective fiscal year 2007, due to a decrease in the interest ratio and decrease in the number of the directors who were dispatched from the Company. The Consolidated Statements of Income for the year ended December 31, 2007 included the Statements of Income of Otsuka Information Technology Corp.

### (2) Elimination of intercompany accounts

For the purposes of preparing the consolidated financial statements, all significant intercompany transactions, account balances and unrealized profits among the Companies have been eliminated in full, and the portion attributable to minority interests is charged/credited to minority interests.

For the elimination of investments in common stock of consolidated subsidiaries, together with the equity in the net assets of such subsidiaries, any difference between such investment costs and the amount of underlying equity in the net assets of the subsidiary is deferred and amortized to income over five years on a straight-line basis.

#### (3) Investments in unconsolidated subsidiaries and affiliates

The Company had five unconsolidated subsidiaries and nine affiliates at December 31, 2006 and 2007.

The Company had one investment in affiliate for the equity method and two investment in affiliate for the equity method at December 31, 2006 and 2007, respectively. Investments in unconsolidated subsidiaries and affiliates not accounted for by the equity method were carried at cost or less, since they did not have a material impact on consolidated net income and retained earnings in the consolidated financial statements.

# (Fiscal year 2007)

Otsuka Information Technology Corp was changed from a consolidated subsidiary to an affiliate for the equity method from fiscal year 2007, due to a decrease in the share ratio and decrease in the number of the directors from the Company.

#### (4) Cash and cash equivalents

Cash and cash equivalents in the consolidated statements of cash flows are composed of cash in hand, bank deposits which can be withdrawn on demand and short-term investments with an original maturity of three months or less and which represent a minor risk of fluctuation in value.

#### (5) Inventories

Inventories are valued by the methods according to the category of inventories as follows:

Merchandise and maintenance parts:Merchandise and maintenance parts are stated at cost mainly determined by the moving-average method

Work-in-process:	Work-in-process is stated at cost determined by the individual cost method
Supplies:	Supplies are stated at cost determined by the latest purchase price

#### (6) Financial instruments

(a) Securities

Securities held by the Company and its subsidiaries are classified into two categories:

#### · Equity investment in subsidiaries and affiliates

Investments of the Company in equity securities issued by unconsolidated subsidiaries and affiliates are accounted for by the equity method. In exceptional cases, investments in certain unconsolidated subsidiaries and affiliates are stated at cost, determined by the moving-average method, because the effect of application of the equity method would be immaterial.

## · Other securities

Securities with market quotations are stated at fair value, based on market prices at the balance sheet date. (Unrealized gains/losses from valuation of marketable securities are charged directly to net assets at a net-of-tax amount, while cost of sale is determined by the moving-average method.)

Securities without market quotations are stated at cost, determined by the moving-average method.

Regarding investments in limited partnerships and similar investments, an amount equivalent to the Company's partnership investment gain or loss under the equity method, with such a gain or loss being based on the latest available financial statements of the corresponding limited partnerships, was recognized in the consolidated financial statements.

# (b) Derivatives

All derivatives are stated at fair value, with changes in fair value included in net profit or loss for the period in which they arise, except for derivatives that are designated as "hedging instruments."

#### (c) Hedge accounting

Gains or losses arising from changes in fair value of the derivatives designated as "hedging instruments" are deferred as an asset or liability and included in net profit or loss in the same period during which the gains and losses on the hedged items or transactions are recognized.

Also, if interest rate swap contracts are used as a hedge and meet certain hedging criteria, the amount to be paid or received under the interest rate swap contract is added to or deducted from the interest on the assets or liabilities for which the swap contract was executed.

The derivatives designated as hedging instruments by the Companies are principally interest swaps, forward exchange contracts and currency swaps. The related hedged items are trade bank loans and accounts payable.

The Companies have a policy to utilize the above hedging instruments in order to reduce the Companies' exposure to the risks of interest and foreign exchange rate fluctuation. Thus, the Companies' purchases of the hedging instruments are limited to, at maximum, the amounts of the hedged items.

The Company evaluates the effectiveness of its hedging activities by reference to the accumulated gains or losses on the hedging instruments and the related hedged items from the commencement of the hedges.

# (7) Property, plant and equipment

Depreciation is computed using the declining-balance method, at rates based on the estimated useful lives of assets, which are prescribed by Japanese income tax laws. Depreciation of buildings newly acquired after April 1, 1998 has been provided based on the straight-line method in conformity with Japanese tax laws.

Estimated useful lives of assets are principally as follows:

Building and structures — 15 to 50 years Other — 4 to 6 years

Normal repairs and maintenance, including minor renewals and improvements, are charged to income as incurred.

#### (Accounting change in 2007)

Effective as of the consolidated accounting period ended December 31, 2007, the Company and its domestic subsidiaries have changed their depreciation procedure based on an amendment in corporation tax law for the tangible assets acquired on and after April 1, 2007. The effect of this change on the financial result is immaterial.

### (8) Accounting for leases

Leases that transfer substantially all the risks and rewards of ownership of the assets to lessees are accounted for as capital leases, except that leases that do not transfer ownership of the assets at the end of the lease term are accounted for as operating leases.

#### (9) Software and other intangible assets

The amortization of costs of software developed for external sales is computed at an amount based on the ratio of actual sales during the year to total estimated sales for the estimated salable period. However, the amortization costs should not be lower than the amount computed based on asset purchase value on a straight-line basis over the estimated remaining useful life of the asset, which is 3 years.

Software developed for internal use is amortized on a straight-line basis over the estimated useful life of the asset, which is mainly 5 years.

Other intangible assets with finite useful lives are amortized using the straight-line method over the estimated useful lives.

# (10)Accounting for income taxes

Income taxes of the Company and its domestic subsidiaries consist of corporate income taxes, local inhabitant taxes and enterprise taxes.

The Company and its subsidiaries have adopted the deferred tax accounting method. Income taxes were determined using the asset and liability approach, whereby deferred tax assets and liabilities were recognized in respect of temporary differences between the tax basis of assets and liabilities and those as reported in the consolidated financial statements.

#### (11) Allowance for doubtful accounts

An allowance for doubtful accounts is provided at an amount of potential losses from uncollectable receivables based on the actual historical rate of losses from bad debts for ordinary receivables, and on the estimated recoverability of specific doubtful receivables.

#### (12) Reserve for retirement benefits

#### (a)Retirement benefits for employees

The reserve for retirement benefits represents the estimated present value of projected benefit obligations in excess of the fair value of the plan assets, the unrecognized actuarial differences are amortized on a straight-line basis over a period of 12 years from year following the year in which they arise, and the unrecognized prior service cost is amortized on a straight-line basis over a period of 12 years.

#### (b) Retirement benefits for directors

The Company and six consolidated subsidiaries have provided for accrued retirement benefits to directors at an amount equivalent to 100% of the benefits the Company would be required to pay, had all eligible directors retired at the balance sheet date.

#### (13) Net income and dividends per share

Net income per common share is based upon the weighted average number of common shares outstanding during each year. Cash dividends per share shown for each year in the consolidated statements of income represent dividends declared as applicable to the respective year.

Diluted net income per common share assumes full exercise of outstanding stock options which have a dilutive effect.

Diluted net income per common share for the year ended December 31, 2006, is not disclosed because there were no potentially dilutive securities outstanding.

# (14) Accounting for the consumption tax

The Japanese Consumption Tax Law generally imposes consumption tax at a flat rate on all domestic consumption of goods and services. The consumption tax withheld upon sale is not included in the amount of "Net sales" in the accompanying consolidated statements of income but is recorded as a liability. Consumption tax, which is paid by the Company and domestic subsidiaries on purchases of goods and services, is not included in the amounts of costs/expenses in the consolidated statements of income , but is offset against the balance withheld, and the net balance is included in "Other current liabilities" in the consolidated balance sheets.

#### (15)Rounding of amounts

Rounding down sums of less than a million yen.

# 3. U.S. Dollar Amounts

Amounts in U.S. dollars are included solely for the convenience of readers outside Japan. The rate of ¥114.15=US\$1, the rate of exchange on December 31, 2007, has been used in translation. The inclusion of such amounts is not intended to imply that Japanese yen have been or could be readily converted, realized or settled in U.S. dollars at this or any other rate.

# 5. Derivative Information

The Companies utilize derivative transactions for the purpose of hedging their exposure to fluctuation in foreign exchange rates on payables denominated in foreign currencies and interest rates on interest-bearing debt, however, do not enter into transactions involving derivatives for speculative purposes.

The relevant derivative transactions are used for hedging are summarizing as follows:

Foreign exchange risk associated with liabilities denominated in foreign currencies: forward foreign exchange contracts are currency swaps

Interest rate risk associated with sourcing funds and investing: interest rate swaps

There remain the risk of foreign currency exchange fluctuations on currency transactions and the risk of interest rate fluctuations on interest rate transactions. As the Companies enter into derivative transactions only with financial institutions which have a sound credit profile, we believe that a credit risk is insignificant.

All risk hedge operations and management are carried out pursuant to the Companies rules which stipulate management policies of derivative transactions, limitation of a hedging position and so forth by treasury department with an appropriate approval.


